#### **PREVENTIVE vs DIAGNOSTIC**

Preventive care is designed to help you stay healthy, and is covered with \$0 out-of-pocket when you see a network provider.

Costs may be incurred for diagnostic care based on plan coverage.

#### Preventive Care

Preventive care includes routine well exams, screenings, and immunizations intended to prevent or avoid illness or other health problems.

- · No symptoms, illness, or history prompting the screening
- · Would be done in accordance with age and gender guidelines

#### **Diagnostic Care**

Diagnostic care includes care or treatment when you have symptoms or risk factors and your doctor wants to diagnose them.

- Symptoms require further diagnosis
- Previous abnormal test results prompt earlier or more frequent screenings
- Previous abnormal test results prompt rescreening

Claims are paid based on the procedure and diagnosis codes submitted. These codes indicate if it's preventive or diagnostic services.

#### **Prescription Drugs**

Prescription drug prices are not regulated. The cost of a prescription may differ by more than \$100 between pharmacies across the street from each other. There are various websites that allow you to price a prescription in your area, with some providing coupons or discount Rx cards. These sites gather current prices and discounts to help you find the lowest cost pharmacy for your prescriptions. Do a quick internet search of "discount prescription cards" and a multitude of options will pop up. Why waste your money on overpriced prescriptions. 
do an internet search, a good place to start is **<u>GoodRx.com</u>**.
