- Dr. White invited Mrs. Aerts, NPHS Biomedical Science Teacher and NPHS HOSA Team Sponsor, to give an overview of the HOSA project that went to State competition and present her State winners going to the National competition in June most of whom were present to discuss. Dr. White congratulated the students and presented certificates to the winners on behalf of himself and the Board.
- Dr. White then congratulated Mrs. Aerts for being chosen as Outstanding Teacher for the "Dude be Nice Foundation".
- Dr. White recognized Mr. Jim Holifield who will be transitioning to Valparaiso Community School Corporation. Dr. White explained that Mr. Holifield's work has been respected and appreciated and that he will be missed. Dr. White also congratulated Mr. Tim Scott who will be stepping into Mr. Holifield's position.
- Dr. White recognized Mr. Mark Norton, Director of Technology for NPUSC, stating that Mr. Norton and his team tirelessly keep NPUSC up to date on technology of which he appreciates. Dr. White gratefully thanked Mr. Norton who applied for a 1.4-million-dollar Emergency Connectivity Federal Grant and won for the corporation. DISCUSSION ITEMS

- (A) Board Policy 8600 Transportation Walk Zones
 - Dr. White reviewed the current walk zones for students in Rolling Prairie and New Carlisle. Dr. White recommended that both of those transportation walk zones be doubled in size to provide for more efficient bus routes. There was no discussion by the Board.

- Mr. King asked for discussion on the tabled handbooks and the Board's concerns.
- Mr. Groves asked about the severe vaping concern at the high school in the bathrooms. He is looking forward to hearing about how to rectify that situation and address it in the handbooks.
- Mrs. Sass and Mr. Scott explained to the Board that they have installed vaping sensors of late which have helped with identifying students along with adding teacher patrols. When caught the student's 1st offense is 1 day of ISS and take a class on vaping. Mrs. Sass stated that they have found that students who vape are addicted as they tend to be repeat offenders. 2nd offense, the student has 1 day of OSS and a ticket for \$168. 3rd time is more days of OSS and another ticket. The ticket seems to be most effective in prevention. Parents are becoming more aware their students are vaping.
- Mr. Groves said that as a parent, he is so sorry that the principals have to deal
 with such time-consuming bologna. He tells his own kids that if they break a
 rule then they have to deal with the consequences. Rules are rules and
 consequences have to be tough to be effective.
- Dr. White suggested giving the ticket the 1st offense and ISS then 2nd offense more ISS days.
- Mrs. Smith suggested keeping the vaping class at the 1st offense along with Dr. White's suggestion then the student pays for the vaping class on 2nd offense and take it again.
- Mr. Williamson suggested the MS mirror the HS rules on offenses.
- Mr. Groves asked about the elementary schools and if students are vaping there. Dr. White responded that there is not information on that.
- Dr. White will put together options for the Board to review for recommendation at the next Board meeting so they can be added to the Handbooks and the handbooks approved.
- Mr. King then recommended that the transportation discipline referral be tweaked removing the current 1st offense then moving the current 2nd offense up to the 1st offense. It has become necessary to be tougher on the students on the bus. Mr. Groves agreed. Dr. White shared Lory Samford has encouraged the drivers take more pro-active steps and make calls to parents. Mr. Williamson stated that the drivers may need to make those calls from the bus garage on a school phone with Lory present. Serious offenses then move on to the Administration. The Board agreed and this should be in the student handbooks as well.

- Mrs. Smith thanked Mr. Holifield for time at NPUSC and congratulated the HOSA students and Mrs. Aerts.
- Mr. Williamson welcomed Mr. Scott and Mrs. Sass to the central office. He then stated that HOSA students work is very impressive. Thanking them for their presentation. Mr. Williamson then thanked Mr. Holifield for his time here and stated that he will be missed and wished him luck.
- Mr. Groves echoed what the Board said.
- Mr. King congratulated the graduating seniors adding that Graduation is on. Sunday, June 5th at Amzie Miller Field. He also thanked Mr. Holifield for his time here and his work with the referendum wishing him luck at Valparaiso Community School Corporation.
