Board Notes

February 26, 2024

The regular meeting of the School Board was held at 6:00 p.m., Monday, February 26, 2024, at New Prairie Middle School in the LGI Room with Mr. Phil King, Mr. Jason DeMeyer, Mrs. Jill Smith, Mr. Dale Groves and Mr. Rich Gadacz present. Dr. Paul White, Superintendent, was also present.

Mr. Phil King, Board President, reviewed guidelines for speaking on agenda items.

There was a motion by Mr. Groves to Amend the Agenda adding Action Item "M" to approve the Athletic Trainer Contract with Northwest Health LaPorte Hospital, seconded by Mr. Gadacz and approved 5-0.

INSTRUCTIONAL PRESENTATION

Mr. Holmquest, NPMS Principal, began his presentation by describing some of the challenges that they see with students post-COVID. He explained that last year negative student behavior had increased on a level that hadn't existed for many years. Mr. Holmquest introduced NPMS Guidance Counselors, Mrs. Harmon and Ms. Walden, and Ms. Jenkins, Social Worker at NPMS, who put together supports for severe disciplinary issues. The team explained their support plans that have proven to be positive for those students this year. In response to those behavior problems, Mr. Holmquest described his behavior intervention plan and student expectations called the Cougar Pride Matrix, stating that behavior issues this current year have, by far, improved.

Mr. Holmquest then explained that the State of Indiana designated New Prairie Middle School a "Purple Heart School" which means that NPMS displays a significant commitment to service members, veterans and their families.

Mr. Holmquest also added that New Prairie Middle School is the first Middle School in the State of Indiana designated as "Heart Safe". He gave a huge shout out to the New Prairie High School HOSA program that are the sponsors for obtaining that designation as well.

Mr. Holmquest introduced Miss Heidi West, the new Assistant Principal at the Middle School who is a great addition to their staff.

Mr. Holmquest then listed the increased number of activities for students this year that have been highly attended. Mr. Holmquest concluded that with academic interventions and behavior interventions they should see success closing academic gaps for students.

Superintendent's Report

- Dr. White thanked Mr. Holmquest and the New Prairie Middle School Counselors for their thoughtful and detailed presentation about the academic supports happening throughout the school. It is exciting to see early interventions in order to prevent situations from occurring have had impact, according to the data presented, which is an excellent effort.
- Dr. White explained that the corporation has a lot to celebrate.
