REPORTS

- (A) Mr. King, Board President, Legislative Report
- For our final legislative update for the year below are some highlights:
- Lawmakers have opted to keep funding for virtual students at 85% of the amount that brick-and-mortar students receive in current law. This is a compromise between the House which proposed giving these students equal funding (100%) and the Senate, which wanted to reduce the funding to 70% over ongoing concerns about virtual schools' performance and transparency.
- The distribution for summer school has been reduced from \$18.3 million per year to \$17.4 million per year Statewide
- Lawmakers did not restore funding for the dual immersion pilot program, Dolly Parton Imagination
 Library, or the internet connectivity fund
- The final budget restores the \$52.6 million in the Charter and Innovation Network School Grant program, which offers those schools \$1,400 per student. But it removes funding for the Charter School Capital Grant, a \$25 million-line item allotted for facility needs
- SB 146 passed both chambers and will be signed by Governor Braun this bill raises minimum teacher pay from \$40K to \$45K (it should be noted NP Schools is currently above the State minimum)
- Partisan School Boards at the beginning of the legislative session both the House and Senate each
 had their own version of Partisan School board language. The House Bill was voted down by an
 overwhelming majority early on. The Senate Bill (SB 287) barely made it through as 2 Senators who
 had committed to vote against the bill changed their vote at the last hour which gave it the 26 votes

needed to pass the Senate and move to the House. Thank you to both Senator Bohacek and Teshka for voting against this bill on the initial vote. SB 287 went to the House and they did a complete overhaul of the bill to look like the original bill that proposed keeping only one part of the Senate version - this passed the House after failing twice with a vote of 54 to 40. Thank you, Representative Pressel, for voting against this bill once again. It then went back to the Senate where the author of the bill pulled it from consideration initially as he did not like the changes the House made. It then went to committee and when it was all said and done SB 287 passed and was signed into law by Governor Braun - once again thank you to Senator Bohacek for voting against the revised SB 287. This means that governing school boards, including this one, can now be partisan. SB 287 gives the candidate the option to claim they are Republican, Democrat, Independent or they can continue to be non-partisan and not claim any party affiliation. We are now in the age of politics in public school boards in Indiana - and since I no longer have to keep politics out of the boardroom, I will no longer have to hold back with my opinions on our fine legislators and the wonderful decisions they make here in the State of Indiana or abroad - as everyone here knows I always have. SB 287 does continue to hold School Board elections during only the General Election and does not recognize Straight Party voting so those folks will still have to vote separately for school board members as they do now.

- HB1500 passed both chambers and now has done away the Teacher Appreciation Grant as we know it
 it will be replaced with a competitive style grant process following yet to be seen guidelines by the IDOE
- HB1515 This bill is a collection of many items that would not pass on their own so were included with a bill that would be passed. One part of the bill has to do with AEDs in schools it requires that only certain individuals and certain schools are to ensure that an AED is operational and present at certain events, and that individuals present at certain events are aware of the location of the AED and emergency plans regarding the use of the AED. Adds a requirement regarding certain school emergency action plans for sudden cardiac arrest. Removes certain sudden cardiac arrest training and certificate of completion requirements. One part of the bill that was able to be removed during the last hour was the elimination of teacher bargaining. Bargaining is vital for teacher working conditions, fair wages and to have a voice that impacts both educators and their students here at New Prairie we are lucky to have a good standing relationship with the teacher's association and respect the work of all of our educators and look forward to continuing that relationship going forward
- SB1 Property Tax Reform and the effect it will have on our Operations Fund and HB 1001 State Tuition Support and the effect it will have on our Education Fund. I will now hand it over to Mr. Scott to give us the doom and gloom these two wonderful bills will have on us. It should be noted that although in both years of the budget we will see a 2% increase, in total, education funding has been cut by 4% in the overall budget (with the exception of the passing of Universal Vouchers costing taxpayers

(B) Superintendent's Report

- Dr. White referenced the presentation tonight first thanking Mr. Holmquest and Miss. West, NPMS Asst. Principal, and the Social Studies Teachers for their excellent presentation tonight. Dr. White explained that the presentation was a perfect example of the deep professional work the teachers have been doing using the PLC process. NP is working on getting ourselves as organized as possible to give your students the best education possible.
- Dr. White then introduced the new Head Boys Basketball Coach at New Prairie High School for the 2025-2026 school year. Dr. White read a Press Release for Coach Lutz expounding on his great success in his young years. Dr. White congratulated Coach Lutz and exclaimed his great excitement for the coming year.
