BOARD COMMENTS

Mrs. Nancy Shail read a heart felt comment for Mr. Shail to the public as follows:

I would like to say a few things about the tragic bus accident that happened on May 8th that has not only changed my life but the lives of the entire New Prairie baseball program and the NP community as a whole.

First and foremost, to the first responders on the scene, thank you. The words sound so shallow in comparison to what each of you do on a daily basis. There were 29 vehicles as I was told and 1 helicopter. I don't remember much but what I do remember it was organized chaos. The men and women on the scene did an excellent job of getting where we all needed to be.

To the St. Joe County Police and LaPorte County Sheriff departments who reacted and tried to do what could be done and stop this maniac. I respect your professionalism and disagree with the criticism under fire your departments have had to deal with for not preventing this unbelievable scene.

Above and beyond the first responders are the other hero's that need to be mentioned. Sophomore baseball player Andrew Enders instead of leaving the bus worked his way to the front of the bus to release coach Bradshaw from his seat belt as he was hanging above the floor and was having difficulty breathing. Andrew showed true courage in an extremely stressful situation. Coach Ryan Curless maintained his coolness and made sure that the less injured players got to a safe place together and made sure they were ok. Jen Sass arrived on the scene very quickly to help coach Curless with the boys and to get them to their parents on the scene or back to the school which was the chosen rally point. Paul Adams our SRO was on the scene as well and I asked for him to contact my wife to give her the news and let her know where to meet me. I didn't want her to find out any other way like social media or from a news channel. I would be remiss if I did not mention all of the people in the NP United School Corporation who are working silently behind the scenes to provide anything

possible in support of meeting the needs to all involved, thank you Dr. White for leading this effort.

And finally, the NP baseball family. Mark and Heidi Schellinger have spent countless hours at the hospital with the Bradshaw family and mine and I am deeply touched with their presence and always seemed to Know when to show up especially when I was having a hard time. This is what true leadership and compassion looks like. So many thanks to my JV boys and their families who made many visits simply to just check in and bring a smile, I want you to know you were the best medicine I had during my hospital stay.

I want to thank the entire New Prairie community and all others, who have shown love and support to all of us involved in this tragedy. your prayers for us are being answered and I am sitting here today because of the strength I have gained from you, let's keep it rolling for the Bradshaw family. Brad, Kelly, Kaleb and most importantly Lucas need our help and support.

In conclusion we will all fight back from this only to be better, we may not all recover 100% but we are all here to live another day.
