## **REPORTS**

- Dr. White highlighted that professional staff returns on Tuesday, August 5<sup>th</sup>, students return on Thursday, August 7<sup>th</sup>. Dr. White reminded everyone that open houses begin Tuesday evening at the secondary levels then the 3 elementary levels are Wednesday evening.
- Dr. White then reminded everyone of the school calendar change that this coming Friday, August 8<sup>th</sup>, is **not** a late start Friday. School will begin at its normal hours.
- Dr. White shared that both himself and NPUSC school board members have received many questions from the community about the future of Olive Elementary given the Amazon and battery plant developments, and with it, likely in-district housing growth. NPUSC is going to host a series of meetings this fall to engage the entire NPUSC community in straight forward dialogue about NPUSC enrollment trends, current building enrollments and utilization, and potential long-term options for strategic planning to maximize current NPUSC facilities and taxpayer funds.

The first meeting will take place Sept 8th at the NPMS Auditorium at 6 pm central time. This meeting will include a straightforward presentation about the current facts of the situation and include an initial opportunity for the NPUSC School Board to hear questions and community input. Follow up meetings will occur later in September and October at both Prairie View and Olive Elementary Schools with additional opportunities to hear the presentation and community input. A more detailed communication with all meeting dates will be published later in August.

After the series of public input meetings, the NPUSC School Board will make any final determinations by early 2026
